



Tuhaqtauyukhaq

Angayukhiit Tikkuaqtauyut Nunavutim Kavamainnut

IQALUIT, Nunavut (Mii 14, 2009) - Hivuliqt Eva Aariak uplumi uqaqtuq tikkuaqtauyumik Mr. Bob Long Tuglianut Ministap Pivalliyuliqiyitkut Ingilrayuliqiyitkunnnullu.

Mr. Long havakhimayuq nanminiqaqtuni, nanminiqaqtut pivalliyuliqiyiinni, nunallaallu pivalliyuliqiyitkunni avatquplig 40 ukiut. Ayunngitait ilalgit hapkuninnga nanminiqaraluaqtuq havakhimaplunilu angiyuni timiuyuni. Nunavunmiutauhimaliqut 1982ngutillugu havakhimaplunilu amigaittunik aallatqiinik, aatjikkivyatunik havaakanik, una ilagiplugu 7nik ukiunik Angiyuqqaangupluni Qikiqtaalungmi Chamber of Commerce – kunni Ikhivautaliugaluaqhunilu Nunavunmi Havaanik Takuyaqturvingmi Katimaniryuanganilu. Kingullirni qulini ukiuni, atan'nguyauvaktuq Qikiqtaalungmi Pivalliatjutikhaliqinirmut Kuapuliissitkunni.

Nan'ngariyauyuq Peter Taptuna, Minista Pivalliyuliqiyitkut Ingilrayuliqiyitkunnnullu, quyagiyaaatikkuaqtuiniq uqaqhunilu “una kavamat uqariiyaqhimaliqtuq, uvani *Tamapta/CL°C: Hivunikhaliurniq atauttikkut*, ikayurumapluni nunallaamiittukhanik, piqutiqaqtunik maniliurutikhanik. Bob Long amigaittunik ukiunik ayuittiaqhimayait piliuriangani nanminiaqrnirmik nunallaanilu pivalliyuliqinirmik ikayurniaqtait kavamatkut havaqatigyaangani nanminiqaqtut tamaitalu Nunavunmiut tikittaangani takuyumayatik.”

Hivuliqtip quyagiyaa Rosemary Keenainak, Tugliata Ministagillaktaa Pivalliyuliqiyitkut Ingilrayuliqiyitkunnnullu, havakpangniagut talvuuna havaami kingullirni malruungni ukiungni. Ms. Keenainak akhuuqhuni kavamatkunni havaktiuvaktuq, havakhimapluni kavamainni Nunattiap Nunavutiplu, 20ni ukiuni.

Ms. Keenainak uqaqtuq “liagivaktatka havakkama hivumuurahuaqtuni havaakhani Kavamainni Nunavutim. Aallamik piumalirama inuuhimni, talvalu ilihariaqtulirniarama ukiakhaq.”

Hivuliqtiplu uqaqtaa tikkuaqtaunia Yasmina Pepa Tuhaqtakħaliqiyitkut Titiraqtianut Hivuliqtimut. Ms. Pepa havakhimayuq Munaqhiliqiyitkunnut Inuuħiringnirmullu Aulapkaiyiupluni Tuhaqtakħaliqiyini. Havakhimayurlu aallani Nunavunmi kavamainni 2003mit tuhaqtakħaliqinirmut ayuittiaqhimapluni, ukuanilu Qulliq Alruyaqtuqtunik Ikumatjiinni ukunanilu Kavamaliqiyitkunni.

Hivuliqt Aariak uqaqtuq “Aliahuktunga Yasmina ilauniarmat ayunngittunut havaktinut Ministat havakvianni. Tamapta, qiniqħia himmaarniaqtugut ihuaqħittiarangani uqaqatigiingniq tamarmik Nunavunmiut. Kingullia, Karen Kabloona, ayunngittuq pipkarmata kavamavut tuhaqtiqattarniagut inungnik quyagiyaralu ikayurmat havaamini kingullirni malruungni ukiungni.” Ms. Kabloona havaliquaq Kavamainni Nunavut Aulapkaiyiupluni Nunaqqaqħimayuliqinikkut Ukiuqtaqtuliqinikullu.
