

# Tuhaagakhaq

## KAANATAUP KAVAMANGA NUNAVULLU PIPKAITJUTAUYUT ILIHARIYUUMIRVIUYUNI NUNALINGNI NAPATJUTINGIKHANGINNIK NUNAVUNMI

**ARVIAT, Nunavut (Saptaipa 23, 2009)** — Nangariyauyuq Leona Aglukkaq, Ministauyuq Aaniaqtuliriniqmut, pitquativlugu Nangariyauyuq Gary Goodyear, Ministauyuq Nunalingnut (Nalunaqtunik Ihivriuqniq unalu Nutaanguqpalliyunik), unalu Nangariyauyuq Daniel Shewchuk, Nunavutim Ministauyuq Avatiliriniqmut, Ministauyuq Havaktuliriniqmut Ministauyurlu Kamayiuyuq Nunavutmi Ilihariaqpaallivinginnut, ublumi uqaqtut avatquumayuq \$4.9 milliat taalamik nunalingni napatjutikhanginnik manikharhiuqtikhat Nunavutmi Ilihariaqpaalliviit Iliharvikhanginnik nunallaanilu inirninut iliharvikhanginnik.

Ilaukmat Kaanataup Manilirutikhamiknut Ihumaliurniq, Kaanatap Kavamangat naunaipkaiyaat Ilihimaniq Nappaqtirinirmut Atuqtakhaq, malruuknik ukiunik \$2-billion taalamik manilirutigiamiknik ikayuriamikni nunalingni napatjutikhanginnik ihuarhainiq Kaanatamiutat ilihariyuumirvikmi igluqpingit, ukuatlu iliharvikyuangit nunallaanilu iliharvingit. Ublumi naunaipkaitjut quviahuutigiyaa tamna havauhikhaq piinarialaquiningga ilihaitjutautikhambut Nunavunmi.

“Kavamavut piqutingit havaakhariiyautiniaqtut tahapkunani nunallaani hakugiktillugiklu Nunavutim akuniraalukmut itjutinga ihivriuqniqmut nutaangurniqmullu,” uqaqtuq Ministauyuq Aglukkaq. “Nutaanguqtirinik iliharviiknik naunaiqtitauniaqtaa ilihaqtut ilihariamiknik ihivriuqtuyullu tuniyauyt atuqtakhamiknik ihariagiyamiknik paqigiamiknik ikayuutautigiamikni Kaanatamiunut inuknllu tamaat nunaryuaptikni.”

Tamna ilihaitjut ikayuqtuq pigiami maniitigut akhururutauniq havaakhaqariamilu havaakhaliurumik hanauyukhanik titrauyaqtiiyuq, piliuqtuyunut, niuvvaiyiuyut niuvrutigiyullu ayuittiarhimayullu. Ikayuqturlu piliuriami hivumuutqayut ayuittiarhimayut nunallaani napatjutingit ihariagiyauyt pigiamiknik Kaanataup ihivriuqvingit iliharvingillu hivunngani nalunaqtunik ihivriuqniq hivumuutqayut.

Tamna maniit atuqtaunngittut uqaqtauhimayut ublumi ilauyuq \$2.2 milliat taalamik kaanatap kavamanganit, uuminngalu \$2.76 milliat taalamik Nunavut kavamanganit.



“Tamna Qaritauyaliriniqmut Nunalingni Napatjutingit Havauhikhat angiyuq talvannga havaariyakhangit ihuarhaigami ilihariaqpaallivingit ilihaitjutingit ikayuutautillu tamainnut nunallaanut Nunavunmi ayurhautiginiaqtaa tamainnut 25nguyunut nunallaanut. Iliuraiyaa tunngavikhanga tuhaqtipkaitjutikhanganik pipkaigami qaritauyakkut ayuirhainiq piinariaqlaqiyumik tamainnut Nunavunmiunut Ilihariaqpaallivikkut,” uqaqtuq Ministauyuq Shewchuk. “Tamna nakuuniaqtuq tamainnut Nunavunmiunut pigumitku ilihaitjutikhanginnik nunagiyamikni.”

Kaanataup Maniliurinahuarutinganik Ihumaliurniq piliuqtuq qilamiurutigami Kaanatamiutat maningitnik malruukni ukiumi ihuarhigiamilu akuniraaluvut akiniarutigyauniq uuminnga \$12 billiat taalamik nutaanik nunalingni napatjutingitnik maniit atuqtaunngittunik, uuminngalu \$2-billiat taalamik Ilihimaniq Nappaqtirinirmut Atuqtakhaq. Una nutaanguyuq ikayuutaut akhuerutauyuq maniknik atuqtaunngittuq Kaanatap Kavamangani amigaittuni-ukiumi Nalunaqtunik Ihivriuqniq unalu Nutaanguqpalliayunik Maligaq, *Pipkaqtailiniq Nalunaqtunik Ihivriuqniq unalu Nutaanguqpalliayunik Kaanataup Ikayuutautinganut.*
