## Minister Taptuna announces changes to NBCC Board

**IQALUIT, Nunavut (August 6, 2010)** – Peter Taptuna, Minister Responsible for the Nunavut Business Credit Corporation (NBCC), today announced changes in the membership of the corporation's board of directors.
