IQALUIT, NU, (Tattiarnaqtuq 3, 2012) – Amihukyuat utiktitquyauyut hapkuat beef-nik niqiliughimayut nakuungitut uminga *E. coli-mik aanniagnaktumik* hamanga Alberta-mi niqiliurvianni (XL Foods) Tadjalu atuqtauyuk. Ilangit uvanga niqqiliughimayut beef-nik hamunga Nunavunmun tikitut.
