Havaarihaaqtaraluanga Ministaup Tugliata Ikayuqtia (Ataniullaktuq) Ayuittiaqhimayuni Havagvia Munarhiliqiyikkut unalu Nunallaanil Havagvia, Kavamatkuni Newfoundland-mi Labrador-milu.
