Nunavut Inminiiqtailinikkut Hanaqitjutikharnik ilagiiktun tuuhaktittaihunguuyut iluumuqguutiggiiblugu

IQALUIT, Nunavut (Ubluqtuhirvia 8, 2016) – Kavamat Nunavut (GN), Nunavut Tunngavik Inc. (NTI), Paliihimatkut (RCMP) “V Havakvia”, uvalu Isaksimagit Inuusirmi Katujjiqatigiit Iqihimalugu Inuuhiq Katimayiingit. tuhatitiyun atayumik iluumuqguutiggiiblugu aulahimaaqlugu ihuaqhiyuumigiangani Nunavut Inminiiqtailinikkut, tautuktuyaangnir hanahimayuq inuit ilaublicit uvalu naunaijutainik – ihivgiugutainit.

Talva ilitugipkaijut maliktuq ilagiyait kinguani ikayuqtut umunga naalaktiuniqmik pitkuyayun hamani 2015 tuquttuligiyit apihuutaini angiyuq amigaingniit inminiiqutait Nunavutmi. Ilagiiktun katimaqatigiitqataqtut ihuaqhaiblutik atuqtahainik ilagiblugu naalaktiuniqmik pitkuyayun uvalu Nunavut Inminiiqtailinikkut uqagiikhimayun.

“Hivunikhaptngni, uvagut inuuvakhimayugut akhuqnartumik havaqatigiikhuta uvalu ikayuqatigiikhuta”, uqaqtuq Paul Okalik Minista havanga iminiiqtailinikkut. “havaqatiikhuta tigublugu ublumi Nunavut Inminiiqtailinikkut, tigumiaqtugut pitkuhiqmik havaqatigiikhuta atauhirmik pinhuaqhuta. Tamapta, havaqatigiit inmingnikluunin, tuniniaqtugut ihumaliugutit umunga iminiiqtailinikkut kinguvaptngnunaqlugu.”
