**QIQAIYALIRVIA 24, 2016 – IQALUNGNI OTTAWAMILU** – Tiibii (TB) qayangnaqtuq inungnun inuuhiinut hivuuganaqtuq Kanatap Tunun’nganiitunun ,qanugiliugutaa naunaitkutaa 40nik anginiqhaqmik aktilanganik kanatap atuqpakniqhat. Tadja inuit Iqalungni Ottawamilu atiliuqtaaqtut naunaiyaqnianik nutaaq havaut aalakiit mighilaqtitiut munaktautjutikhnik takunaitumik TBiiktut hamanga 9 tatqiqhiutit tualunun havainiq.

Uvanga quyagiyaga Dr. Alvarez havaqataitlu havaktut uminga Taima 3HP naunaiyainikut pihimayuq nutaamik aupangniq munaginingmik.”

“Tiibii alangutaa inuhiga, ” uqaqtuq Margaret Ishulutak angnaq Iqalungmiutaq naunaiqhimayuq aanniarutauyumut Tiiimik ukiuqmi 2014mi. “Uvanga inmikkut igluami igluniluuniit ittuqhauyut ahinungaulimaittumik hitamanik havainini amigaitunik havautituqtauyunga hananik amaigaitunik tatqiqhiutinik mamitinanga.
