Hivuliqtii Yukon, Nunatsiaq Nunavunmi uqautiginahuaqtait ihumagiayayunik ukiuqtaqturmiunit Hivulliit Ministauyut Katimayunut Vancouver Qiyaiyalirvia 3rd.

Yukon Hivuliqtia Darrell Pasloski, NWT Hivuliqtia Bob McLeod unalu Nunavut Hivuliqtia Peter Taptuna Nigiukhimayunga taima havaqatigyaangata tamaita Hivulliit Ministauyut, uqautigiyariaqaqtaqqut akhuurnaqpiaktuq qanuriliurutikhaptingnik hilaup aallanguqtirninganut.

Ilihimaliqtugut angiyumik hilaup aallanguqtirninga mihingnakhiyuq ukiuqtaqtumi nunallaani, aviktuqnini Hivuliqtii piyumaqpiaktut uuktutikhaptingnik qanuriliurutikhaniCLU nakatqingnahuarutikhaniLU hilaup aallanguqtirninganut tikittumayavut pinahaqaqtakhavut ihumagiayakhangitlu tadja atuqtauliqtunik tamaini ukiuqtaqtumi aviqtuqnini.

“Ukpirriyunga tamna alungnup puya nakuunngittuniklu aktuutiqarniaqtut inuuhiptingnut atuqluaqtayunik Ukiuqtaqtumi. Kanatami hilaup allanguqtirutikharnik hivunikhat aulayukhat talvuuna hanaqidjutikharnik taima aulangitunik ayungnautikharnik Tununganiitunik akingit inuuhmaagianganik, ayuqhaqtinahuarnaitumik niqailiurnikkut, ayukhaqtitiyaangatluuniit aulayunik maniliukhimaqaqtunik,” Yukon Hivuliqtia Darrell Pasloski uqaqtuq. “Tadja maniliurutikharnik akhuurnaqhivallaqtuqlu ayurnaqhivaliapluni, uvagut aviktuqnini Hivuliqtii uukturiaqaqtut maniliurutikharnut aktuutauyut uukturumayainik kavamangita hilaup aallanguqtirninganut qanuriliurutikhaliuktait pinahuangitkaluakhutik ihuirutinahugittutik avikturniini imaniliurutikhainut.”

Aviktuqhimaniit mikyuugaluaktut kihimik anginiqaqtut aviktuqhimaniinut maniliurutikharnik inuqqikitugaluakhutik amigaitilangit mikiyuni tikinnalaitunillu nunani mikinikhauuyut ilangani Kanatami tamainut puyuryuangit aannianiiinut ikianun. Taimattauq, hilaup aallanguqtirninganut pidjutaualiqtuq mihingnaqtunik Ukiuqtaqtumi nunallaani. Taimaitumik kangiqhipkaiyumat Hivuliqtii naunaikhiyt tamarmik pingahut aviktuqhimaniini pinahaqaqpaliqtut munariyakhamingnik qanuriliurutikhaniCLU atuqtakhaliukhutik pihimayait mikhilaqaqnahugittutgit puyut anianiit atuqtittivlutiklu halumatqiyaniq auladjutikharnut atuqtakhainut, hanayauhimayunut nakuuyullu ihuaqhaidjutikharnut.

Ukiuqtaqtumi Hiviliqtiit piyumayut taimatut naunaiyattiakhimayunik maniliurutinut naunaiyarniit iniqtauyukhat nutaanut nunaryuami uuktuutikhaliuktainik hilaup aallanguqtirninganut, ilauyariaqaqtutlu naunaiyautikhinanik ayungnautingnun aviktuqhimaniiun manliurutikhinanut.

"Avikturviit hivuliqtiiuyut talvani hilaup aallanguqtirninganut atuqtakhalierutikhinanik pidjutaungmata hivuliuyuni ayungnautingnik tadja atuliqtapttingnik," NWT Hiviliqti Bob McLeod uqaqtuq. "Nigiukhimaniaqtugut havaqatigilugit Kavamatuqatkut Kavamait naunaiyayaangat Kanatami nunaryuami qanuriliurutikhaliuktainik hilaup aallanguqtirninganut maliqayanginik aviktuqhimanik ayungnautingnun atuqtakhalierutikhimanik."

Aviktuqhimaniiini Hiviliqtiit quviahuktut uqaqatigiiktukhanut aviktuqhimaniiini hivuliqtuqatimingnik tamnalu Kanataup Angiyuqqaaqyuanga hivumuupalladijtikhikaniklu havaaktaulqtunik tamainit nunagiayayuni ihuaqhautikhaliuktainik hilaup aallanguqtirninganut ayukhautauhimaqtunut.

"Ukiuqtaqtumi Kanatap atauttimut puyuryuangit aannianiiinut ikianun mikiyuyaktugaluat, akhuraluk akltuutauyunik atuqpaktugut pidjutainik hilaup aallanguqtirninganut turrangayunik hulipkaidjutainut hanaviryuanguyunut nunaryuami," Nunavut Hiviliqti Peter Taptuna uqaqtuq. "Taimaitumik uqautigivaktavut naunaiyattiakhugitlu kangikhidjutikhinanik atuqtakhalierutikhikaniklu, piyariaqaqtugut kangiqhipkarnahuaglugit ahiiini nunaqaqtut avaliqangitunik ayungnautigiyanginik Ukiuqtaqtumi pidjutaullayuniklu maniliurutikhaptngnut atuqtakhaliektunut qanuriliurutikhinanik upalungaiyautikhaptngnik hilaup aallanguqtirninganut."
