GN services during the holiday closure

Start Date: December 16, 2024 End Date: January 2, 2025

Nunavut-wide 10 min

All Government of Nunavut (GN) offices will be closed from 5 p.m. on December 23, 2024, to 8:30 a.m. on January 2, 2025, except for designated facilities that must stay open. Those facilities are:

Health

Iqaluit Health Services

- The Qikiqtani General Hospital (QGH) will remain open with full inpatient, pharmacy, and emergency services.
- The following Iqaluit Health Services will be open at a reduced capacity:
 - Ambulatory Care Clinics (QGH Clinics and Family Practice)
 - Rehabilitation Services
 - Igaluit Case Management
 - Public Health Services
 - o Home and Community Care Services
 - Diagnostic Imaging
 - Health Records
 - Environmental Services
 - Biomedical Services
 - Materials Management
 - Central Sterilizing and Reprocessing
 - Surgical Services for emergencies only (no scheduled surgeries)
 - Laboratory services

Qikiqtaaluk, Kivalliq and Kitikmeot Region Health Services

- Community health centres will operate on emergency services during the holiday closure period with 24/7 on-call services for urgent and emergency care remaining available.
- Postponed services:
 - o Routine clinics such as chronic disease management, well- child, and

well-woman/well-man clinics.

- The following core services at community health centres will be maintained:
 - Prenatal clinics for high-risk clients.
 - Urgent and emergency appointments.
 - Medical travel services.
 - Community members are advised to call ahead before visiting the health centre.
- Health centre staff are deemed essential and thus will work during the holiday closure dates, as scheduled by their supervisor.
- Continuing Care Centres and Elders' facilities will be fully operational during the holiday closure period.

Public Health

- Public Health Nurses, Regional Communicable Disease Coordinators, TB Coordinators, and support staff will work at reduced capacity.
 - o TB programs and TB care delivery will function at full capacity.

Lab and Diagnostic Imaging

- Kitikmeot laboratory and diagnostic imaging services remain open for emergent, urgent, and necessary testing requirements only. Routine collection and testing of lab work will be suspended during this period.
- Kivalliq and Qikiqtaaluk laboratory and diagnostic imaging services remain fully operational during the holiday closure.

Mental Health and Addictions

- Mental Health Nurses and consultants will function at full capacity.
- Mental Health and Addictions paraprofessional staff will be off while remaining available to be called in at the discretion of the Mental Health Regional Manager.

Finance

The Nunavut Liquor and Cannabis Board (NLCB) will be closed between December 24, 2024, and January 2, 2025. Requests for Special Occasion Permits (SOPs) and Change of Hours for this period should be submitted by Wednesday, December 18, 2024.

The NULC will continue selling low-alcohol content products (beer, wine, cider, coolers) through its Iqaluit and Rankin Inlet stores during the holiday closures, but with reduced hours.

- Community Justice Offices will be closed but Emergency Protection Orders are available by calling 1-844-534-1038 or by calling the local RCMP detachment for assistance.
- The Nunavut Court of Justice will be closed, but standard necessary arrangements will be made to ensure bail hearings and Emergency Protection Orders are adjudicated without delay.
